1. OVERVIEW

MIBCON NDC, **s.r.o.** strives to be a leader in environmental sustainability and believes that a successful future for our business and the customers we serve depends on the sustainability of the environment, communities, and economies in which we operate.

MIBCON NDC is the leader in implementation of SAP Analytics Cloud solutions in Switzerland and one of the key players in Germany and Austria. The team realized more than 100 projects in the BI/EPM area using SAP cloud and on-premises solutions.

Mibcon solutions are being used by international companies from different industry segments such as Insurance, Pharma, Telco, Banking, Automotive, Sports, Retail on Food & Beverage. As an example, the company has successfully rolled out a planning solution for United Nations used across 178 countries. - Steps are taken to implement the right corrective measures to reduce the environmental impact of the company's activities.

5. ENVIRONMENTAL OBJECTIVES AND MEASURES

Our company strives to meet internally set environmental objectives so that improvements in the company's systematic environmental management are gradually achieved. Objectives:

- 1. Compliance with national and European environmental legislative obligations.
- 2. Ensuring full separate collection of municipal waste components
- 3. To move away from landfill waste management
- 4. Minimising the consumption of office supplies (paper)
- 5. Ensuring energy savings

To realize the above-mentioned objectives, it is necessary to take measures to achieve the internal environmental objectives of MIBCON NDC, s.r.o. It is desirable to keep abreast of any new changes in relevant environmental laws and regulations. Ensuring consistent segregation of waste within the company and thereby increasing the recoverability of otherwise unusable material. In addition, the use of electronic data storage is key to reducing the consumption of office supplies, especially paper. This measure also prevents the company from generating paper waste. Finally, energy saving measures should be taken by installing equipment that uses less energy (e.g., LED lighting).

Measures to achieve environmental objectives:

- Compliance and fulfilment of all legislative requirements in the field of the environment
- Acquisition of containers for separate waste segregation
- Emphasis on waste management according to the waste hierarchy
- Maximising electronically stored data
- Installation of equipment with lower energy consumption (LED lighting, etc.)
